Rules & Information Sheet
2010 Mutton Bustin

Each contestant is required to pay a \$10.00 entry fee. Money order, cashiers check or personal check must accompany the entry to be valid. (No cash please). Please make payment payable to the ***Adams County Fair***.

All entries must be postmarked by Friday, July 16, 2010. Mutton Bustin will be held on Wednesday, August 4th, in conjunction with the COORS Light Open Rodeo at the Adams County Fair.

Entry forms will not be accepted without CONTESTANT WAIVER AND RELEASE FORM.

The first 16 entries will be accepted.

Weight limit is 60 lbs. on the day of weigh-in. Weigh-in will take place at the contestant entry area located west of the arena grandstand beginning at 7:30 p.m. Participants must weigh-in or they will be disqualified from participating.

No youth under 4 years of age nor over 7 years of age may participate.

Helmets will be provided and are MANDATORY.

Long sleeve shirts and pants are required.

NO PARENTS ARE ALLOWED IN THE ARENA.

Photography must be taken on the outside of the arena.

No ropes or spurs are allowed.

Contestant and one parent/guardian do not need to purchase a ticket to the COORS Light Open Rodeo. Only one parent or legal guardian will be allowed by the chute gates for mutton bustin. All others must be seated in the grandstands. **THIS WILL BE STRICTLY ENFORCED.**
