Overview of SB 19-181

Gov. Polis signed SB 19-181 on April 16, 2019

- Reconstituted the Commissioners (twice)
- New mission for the COGCC
- New local government authority over surface impacts and siting
- Directed COGCC to undertake numerous rulemakings





SB 19-181 Rulemakings: Completed

500 Series (COGCC hearing process), July 2019

Flowlines (pipelines that COGCC regulates), November 2019

Wellbore Integrity (groundwater protection), June 2020

Mission Change (change from foster to regulate), November 2020

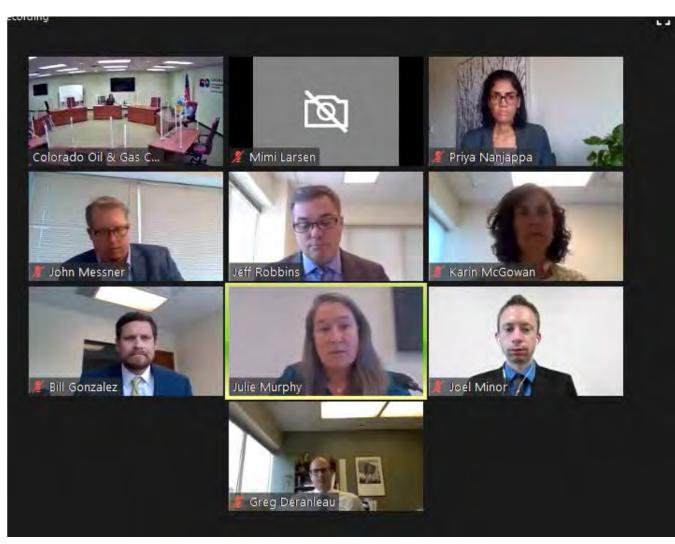

SB 19-181 Rulemakings: Process

- Implementation: move the statute into rules

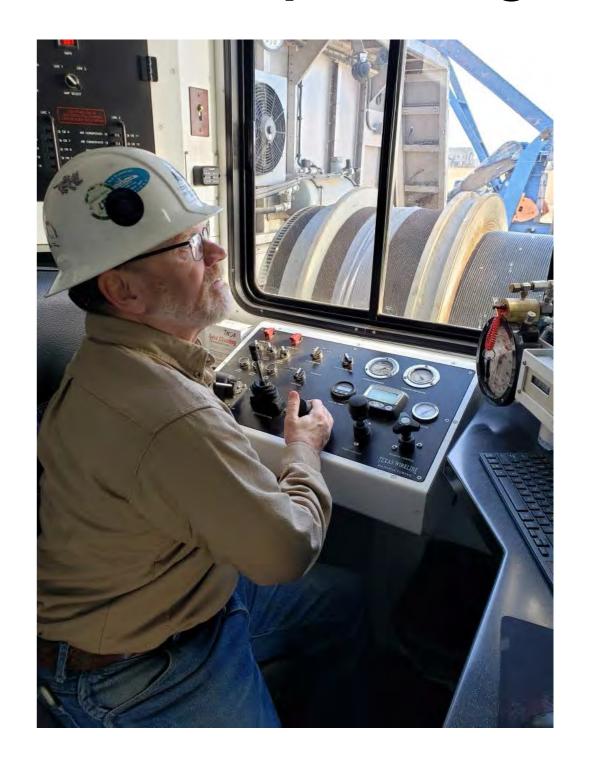

 - 1. The well location is already within an approved comprehensive drilling plan or comprehensive area plan.
 - 2. Specific equipment that has the greatest noise and emissions, including wells, tanks, separation equipment, or compressors are located more than 2,000 ft. from buildings.
 - The commission finds after a hearing that companies have taken "substantially equivalent" protections for public health and safety.
 - 4. A property owner or tenants sign a special waiver agreeing to have a well pad built closer than 2,000 ft.

- Strengthen protections for groundwater
- Adopt Colorado's first-ever substantive regulatory requirements
- Incentivize underground injection of waste fluids as a best practice for management

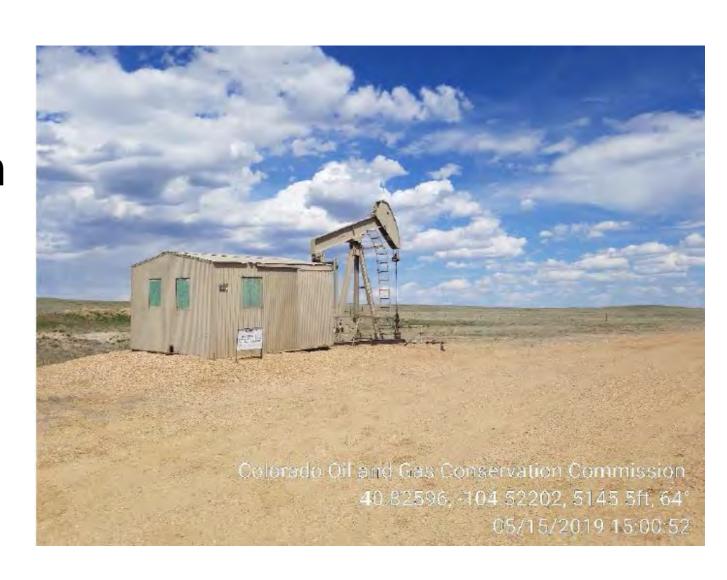

- Evaluate the cumulative impacts of oil & gas development through Commission's "CIDER" database



1200 Series- Environmental Impact Prevention

- Require avoidance of Colorado's most critical habitats

- Protect aquatic habitats
- Minimize disturbance in big game winter range & migration corridors

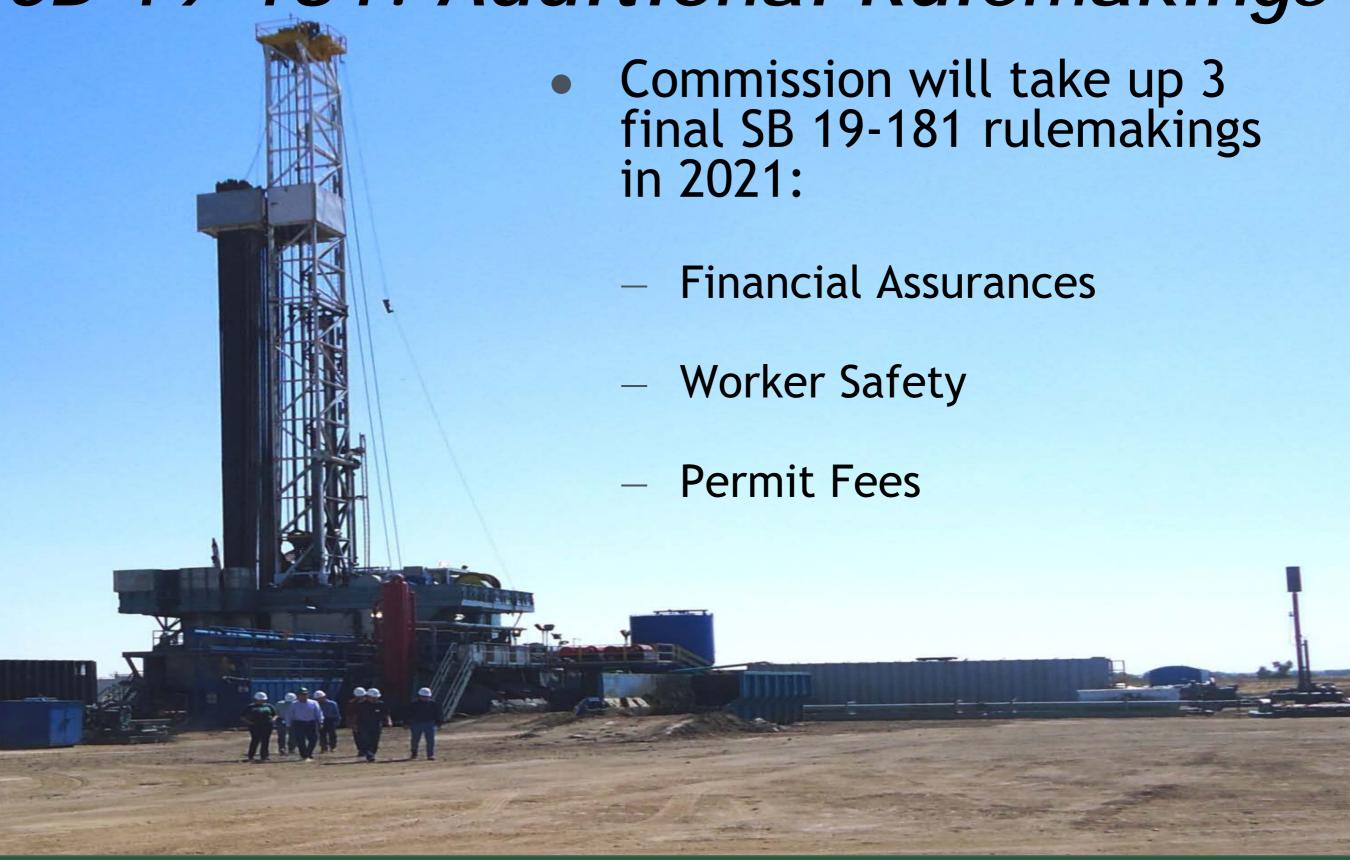


Mission Change Implementation Next Steps

Jan. 15, 2021: Effective date for Rules

- Extensive outreach and guidance for operators, stakeholders, Staff
- 14 Online Forms: Revised 11 forms & created 3 new Forms
- COGCC is able to receive new permit applications
- Replace permits under new rules
 - By March 1, 2021: Operators to notify COGCC which of the current well locations & well applications they will replace

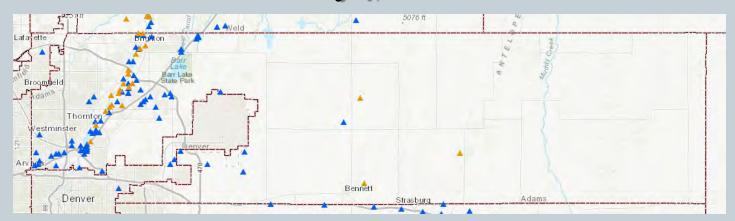

DRMS Jurisdiction

4

- The Mined Land Reclamation Board is the agency established by the General Assembly to promulgate mining operation permit regulations and reclamation standards, which includes identifying what is or is not a reclamation standard.
- **DRMS** Administers the Colorado Land Reclamation Act for Extraction of Construction Materials C.R.S. 34-32.5-101 *et seq*.
- DRMS Oversees aspects of reclamation and off-site damage.



Construction Materials:

- Colorado Land Reclamation Act for the Extraction of Construction Materials, 1995 as Amended, CRS 34-32.5-101 et seq.
- Minerals Rules and Regulation of the Colorado Mined Land Reclamation Board for the Extraction of Construction Materials.

Hard Rock:

- Colorado Mined Land Reclamation Act, as Amended, CRS 34-32-101 et seq.
- Mineral Rules and Regulations of the Colorado Mined Land Reclamation Board for Hard Rock, Metal, and Designated Mining Operations.

• **34-32.5-102. Legislative declaration.** (1) The general assembly hereby declares that the extraction of construction materials for government and private enterprise and the reclamation of land affected by such extraction are necessary and proper activities that are compatible. It is the intent of the general assembly to foster and encourage the development of an economically sound and stable extraction materials industry and to encourage the orderly development of the state's natural resources while requiring those persons involved in extraction operations to reclaim land affected so that it may be put to a use beneficial to the people of this state. It is the further intent of the general assembly to conserve natural resources, aid in the protection of wildlife and aquatic resources, establish agricultural, recreational, residential, and industrial sites, and protect and promote the health, safety, and general welfare of the people of this state.

Objectives of Minerals Regulatory Program

- **Objective #1:** Promote the responsible development of the State's mineral and energy resources while protecting public health, safety, welfare, and the environment.
- **Objective #2:** Reclaim mineral mined acres to beneficial post-mining land use.
- **Objective #3:** Protect the environment by ensuring regulatory compliance at mineral mine sites.
- **Objective #4:** Coordinate permitting, regulatory, and public review processes with federal, state and local agencies, and implement interagency agreements for groundwater, storm water, point source and mine waste issues.

DRMS Jurisdiction

Bonding – DRMS is the only authorized agency to require bonding/financial warranty.

C.R.S. 34-32.5-109(3)

No governmental office of the state, other than the Board, nor any political subdivision of the state shall have the authority to issue a reclamation permit pursuant to this article, to require reclamation standards different than those established in this article, or to require any performance or financial warranty of any kind for mining operations.

DRMS Jurisdiction

CRS 34-32.5-109(3) (cont'd)

The operator shall be responsible for assuring that the mining operation and the post mining land use comply with city, town, county, or city and county land use regulations and any master plan for extraction adopted pursuant to section 34-1-304 unless a prior declaration of intent to change or waive the prohibition is obtained by the applicant from the affected political subdivisions. Any mining operator subject to this article shall also be subject to zoning and land use authority and regulation by political subdivisions as provided by law.

County Authorities

- DRMS does not decide "Should a mine be at this location?"
- **DRMS** no jurisdiction over matters controlled by other agencies or local government/municipalities (i.e., noise, dust, traffic, hours of operation, visual impacts, aesthetics).
- Counties have the authority to permit all aspects of land use for mining, including the location of mining operations.

Minerals - 112c Reclamation Permit Application



- Application must meet the requirements of the Act and Rules to be considered filed.
- Applicant must publish newspaper notice 4 times, once a week, for 4 consecutive weeks.
- Division's decision due within 90 days / extend by 60 days if application considered complex per Rule 1.4.1(7).
- If objections are received, the matter will be scheduled before the MLRB before the 120th day /180th day (if complex).
- Required bond/financial warranty is actual current cost of fulfilling requirements of reclamation plan.

<u>After Application is Filed, the Division sends Notice to the following agencies:</u>

- <u>The Colorado State Historical Preservation Office</u> regarding properties of historical significance including the need for an archeological survey, procedures for requesting a file search, and inventory forms to identify structures.
- <u>Colorado Division of Water Resources</u> regarding the administration of water rights.
- <u>Colorado Department of Public Health & Environment, Water Quality Control Division</u> regarding the discharge of pollutants into State waters.
- <u>Colorado Department of Public Health & Environment, Air Pollution Control Division</u>, regarding the need for a fugitive dust permit.

After Application is Filed, the Division sends Notice to the following agencies (cont'd):

- <u>U.S. Bureau of Land Management</u> or the <u>U.S. Forest Service</u> for proposed operations on federal lands.

- The County Planning Department for the county or counties in which the proposed operation is located. Section 34-32.5-109(3), C.R.S., as amended, requires a mining operator to be responsible for assuring that the mining operation and the post-mining land use comply with local land use regulations and any master plan for extraction adopted pursuant to Section 34-1-304, C.R.S.

Public Participation

18

- Comments and objections are allowed on all permit applications, amendments, surety releases, etc.
- Division consideration is limited to jurisdictional issues as dictated by the Act and Rules.
- Timeframes for Division consideration of comments and objections are defined by the Act and Rules.

Permit Application/Reclamation Plan Review



- Evaluate that each application and exhibit complies with the requirements of the Act and Rules.
- Evaluate if the mining and reclamation plan complies with the performance standards.
- Evaluates whether the plan will meet the stated postmining land use
- Assures the plan has enough detail to calculate an adequate reclamation bond/financial warranty
- Ensures that environmental compliance continues even if the mine is not in operation

Bonding/Cost For Reclamation



- Based on approved Reclamation Plan.
- What it would cost the State of Colorado to reclaim the site in the event the permittee could not fulfill obligations of the approved permit, and the permit is revoked and the bond forfeited (by the MLRB).
- Indirect Costs (profit, administration fees, project mgmt. fees, insurance) are included in the bond amount.
- Updated periodically by the Division.

MLRB Authority – Minerals

- Division staff has authority to make decisions on 112c applications, <u>unless the action receives an objection</u>, in which case the MLRB hears and decides the permitting action.
- All other actions or decisions can be appealed to the MLRB.
- All Minerals enforcement actions are brought to the MLRB for consideration and decision by the MLRB.

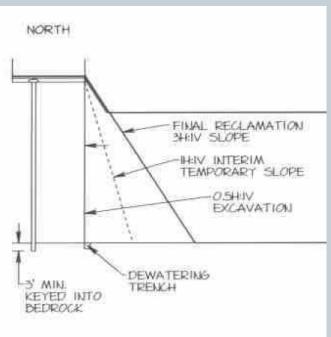

General Reclamation



- Establishing a Post-Mining Land Use
 - Rule 3.1.1 The Operator shall choose the post mine land use in consultation with the landowner.
 - Must comply with:
 - **The United States Laws**
 - **×** Other Colorado Laws
 - Local Permits/Licenses and Approvals
- Compliance with Reclamation Performance Standards as outlined in Rule 3
 - Materials handling, hydrology, topsoil, revegetation, etc.

General Reclamation



- Time Limit and Phased Reclamation Rule 3.1.3
 - Each phase of reclamation shall be completed within five (5) years from the date the Operator informs the Board or Office that such a phase has commenced, or from when mining ceases.
- Generally it takes at least three to five growing seasons for the vegetation to be established enough for final release of bond.

Coordination with the Colorado Department of Public Health and Environment (CDPHE)

- Water Quality Control Division (WQCD)
 - Administers and enforces the water quality programs adopted by the Water Quality Control Commission with respect to:
 - Surface water discharges
 - Groundwater quality
 - Set water quality standards
 - ▼ DRMS is an "Implementing Agency" adopt and implement approaches to protect water quality standards and classifications.

Coordination with CDPHE

33)

- DRMS responsibilities regarding water quality:
 - Minimize disturbance to the hydrologic balance of surface and groundwater system.
 - Work with WQCD to establish points of compliance for statewide and site-specific standards and classification for discharges into state waters, other than surface waters.
- Communication between DRMS and WQCD
 - Quarterly meetings
 - DRMS provides notice to WQCD for all applications
 - **▼** If DRMS expects the surface or groundwater system may be negatively impacted we will coordinate with WQCD on applicable standards.
 - Adopt a monitoring program to monitor for impacts and compliance with WQCD standards
 - Annual reporting to WQCD
- Coordinate on Enforcement Actions

Coordination with CDPHE



- Hazardous Materials and Waste Management Division (HMWMD)
 - Milling Hard Rock ore is regulated solely by DRMS
 - × No Certificate of Designation (CD) is required
 - Waste Imported During Mining Operations:
 - Must get a CD or a Beneficial Use Determination (BUD) from HMWMD except for inert material per DRMS Rule 3.1.5(9).
 - Local governing body has the authority to determine if a CD is shall be required.
 - Mine sites used as landfills <u>as</u> a Post Mining Land Use
 - **DRMS** notifies HMWMD of any application where the applicant proposes a landfill as a post mine land use.
 - Operator will be required to get a CD or a BUD

Inert Material Used As Fill

35

- Inert Material (Rule 1.1(22))
 - Non-water-soluble and non-putrescible solids together with such minor amounts and types of other materials, unless such materials are acid or toxic producing, as will not significantly affect the inert nature of such solids. The term includes, but is not limited to, earth, sand, gravel, rock, concrete which has been in a hardened state for at least sixty (60) days, masonry, asphalt paving fragments, and other inert solids.

Inert Material Used As Fill



- Rule 3.1.5(9) Allows for off-site inert material to be used as fill.
 - Operator must supply a notice that includes:
 - **x** a narrative that describes the approximate **location** of the proposed activity;
 - the approximate volume of inert material to be backfilled;
 - x a signed **affidavit** certifying that the material is clean and inert, as defined in Rule 1.1(22);
 - the approximate dates the proposed activity will commence and end, however, such dates shall not be an enforceable condition;
 - x an explanation of how the backfilled site will result in a postmining configuration that is compatible with the approved postmining land use; and
 - a general engineering plan stating how the material will be placed and stabilized in a manner to avoid unacceptable settling and voids

Coordination with Division of Water Resources (DWR)

37

Authority overlap

- Compliance with Colorado water laws and regulations governing injury to water rights
- DWR is the primary agency authority administering water rights

• Review of Permit Applications:

- DRMS sends notice of applications to DWR
 - **➤** DWR responds with information about possible impacts to water rights.
 - **Applicant must comply with requirements of DWR.**
 - Obtain well permits, substitute water supply plan, permanent augmentation plan, certification of pit liners.

Bond Release

- DRMS notifies DWR of a bond release request.
 - Applicant is required to comply with DWR requirements prior to bond release.

RECOMMENDED ACTION: The Board of County Commissioners has an opportunity to review options around moving to biweekly payroll in 2022.

DISCUSSION POINTS:

Transitioning to biweekly pay will result in a two-week gap for the first pay period of 2022 (January 1 – 14). The first official pay period will end on January 14. Those hours will be paid on January 28.

The following options are given as considerations to help employees transition from Monthly to biweekly pay and help bridge the two-week gap in pay.

Biweekly Payroll Transition

May 18, 2021





Background:

Transitioning to biweekly pay will result in a two-week gap for the first pay period of 2022 (January 1-14). The first official pay period will end on January 14. Those hours will be paid on January 28.

The following options are given as considerations to help employees transition from monthly to biweekly pay and help bridge the two-week gap in pay.



Consideration 1:

On January 14, 2022, the AEI payment could be paid as a lump sum. This amount, if equal to last year -4.2%, would be just over what the bi-weekly salary amount of 2021 would have been. Going forward, since the AEI had been paid as a lump sum in advance, the rest of 2022 would be paid at the 2021 biweekly salary amount. At the end of 2022, the full salary amount paid would be the basis for any salary adjustment in 2023. There is no adjustment needed when an employee terms employment with the county since this is not an advanced payment.





Consideration 1 Cost:

Using current salaries as a starting point, the amount for 4.2% AEI is \$6,907,535.



Consideration 2:

On January 14, 2022, a gap payment equaling two weeks of the employee's regular schedule would be paid if requested by the employee during November open enrollment. When the employee terms employment with the county, this gap payment would be taken out of the last check since this is an advanced payment.





Consideration 2 Cost:

Using current salaries as a starting point, the amount is \$6,907,535 for AEI and \$6,591,256 for the gap payment totaling \$13,498,791. The gap payment of \$6,591,256 would be repaid when the employee leaves employment with the county.



County Manager Recommendation:
