A complete abatement for tax year 2012 was granted by the Assessor's Office because of the deletion of common area taxes that should not have been created, see attached Tax Roll Correction sheet. The abatement information was presented to the Treasurer's Office in late April.

A redemption of the abated portion of the tax lien needs to be done. Since the abatement is for the complete tax amount for year 2012, the entire interest due the tax lien investor for that year will need to come from the County General Fund. The original tax sale amount will be recouped from the authorities for that year.
