

## 2024 VOLUNTEER WAIVER & RELEASE FROM LIABILITY

By my signature below, I certify that I have read, understand, and accept the following representation, stipulations, and waiver. I understand that I am being considered for a volunteer position at Adams County's Riverdale Regional Park and that I am not entitled to any benefits of employment or any of the rights and guarantees afforded to Adams County employees. I understand that my position as a volunteer can be terminated at any time, for any reason, and that I have no legal right to continued participation as a volunteer. I further understand that Adams County, its officers, employees, agents, representatives, and volunteers (hereinafter referred collectively as the "Releasees") will not accept financial or legal liability for any injury or occurrence arising from Adams County hosted events or activities and that accordingly, my participation in such activities must be at my own risk.

I understand that my operation of any type of vehicle in this event subjects me to all laws and requirements respecting operation of that vehicle, and I agree to abide by all applicable laws. I agree that I shall not operate a personal vehicle for volunteer activities unless I have at least the minimum amount of liability insurance required by Colorado law. I understand that due to the expected crowd volume, no four wheelers or motorcycles will be used on the grounds. Golf carts, gator or mule vehicles will be allowed. All safety rules and speed limits will be strictly enforced with no exceptions. I agree to abide by all of the policies and procedures of Adams County and the Adams County Parks, Open Space, and Cultural Arts Department. I agree that I will not engage in any activities on behalf of Adams County without the express permission of my supervisor and that I will only perform those duties specifically assigned to me.

I hereby waive, for myself, my personal representatives, heirs and next of kin, all claims which I might have against the Releasees for injury, accident, illness, property damage, death or other occurrence arising in any manner whatsoever out of my participation in activities sponsored by the Adams County. I expressly assume all risks of my participation in the events at Riverdale Regional Park.

Furthermore, I agree to indemnify, save and hold harmless the Releasees from any and all losses, costs, damages, expenses and attorney's fees arising out of my participation as a volunteer or the participation of persons who accompany me in Riverdale Regional Park Events related activities.

By my signature, I acknowledge that I have read and understood the releases and waivers contained herein, that I am over the age of 18, and that I intend for this document to be legally binding. To the extent permitted by law, this document shall include my child or children and my capacity as guardian for them if I am signing on their behalf for their participation as a volunteer.
