

APPLICATION: CONSTRUCTION WAYFINDING GRANT

Introduction

Adams County's Economic Development Division is offering a pilot grant program, the Construction Wayfinding Grant, to help businesses experiencing construction by county Capital Improvement Program projects to help them market and guide patrons to their establishment/business as a means to help their current and prospective customers way find through changing traffic patterns.

This pilot program will continue until funds are exhausted, and applications will be evaluated and considered on a first come, first serve basis. If a business meets the eligibility requirements, they may be eligible for a one-time grant award amount of up to \$2,500.

Please note that grant funds, if awarded, are subject to taxation. Please consult with your own tax advisor for further information.

Eligibility Requirements

Businesses must be located on the street of an Adams County Capital Improvement Project with construction, occurring or planning to occur directly, in front of their establishment. In addition to the above, the business must also:

- Be a for-profit business
- Have a storefront or showroom (in-person customer traffic) and can describe how construction and/or changing traffic patterns has affected their customer base in finding their business
- Be registered and in good standing with the Colorado Secretary of State
- Have no open code violations and abides with Adams County Development Standards and Regulations
- Be current with property taxes and have no outstanding judgements from Adams County, or have a payment plan in place with County as of January 1, 2024
- Have 100 or fewer employees
- Have been in operation since January 1st, 2024 or longer

Review

Applications will be reviewed weekly by Adams County's Economic Development division. Applicants will be notified of an award within two weeks of their application submission. Funds will be disbursed within 30 days after notification of award.
