

### **ABOUT ADAMS COUNTY**

Adams County is a growing county in the Denver metro area with an abundance of land development opportunities that are unparalleled in the region. The county is ideally located at the crossroads of the metro region's transportation network, which provides businesses and residents convenient access to I-25, I-70, I-270, and I-76. Adams County also surrounds **Denver International Airport (DEN)**, connecting it to the global transportation network of the world's sixth busiest airport, and features **Class I** and **Class III** rail lines, providing freight rail service to and from national destinations. The Regional Transportation District (RTD) provides commuter rail service throughout the western portion of the county.

Adams County has a current population of approximately **542,636** residents, which is projected to grow to **780,085** by 2050. To support and encourage economic growth throughout the county, Adams County considers economic development a strategic priority.

# **ECONOMIC DEVELOPMENT SERVICES AT ADAMS COUNTY**

The Adams County Economic Development Division is here to guide you and ensure you have the resources needed for a successful business. Whether you are a home-based business, solopreneur, have a brick and mortar, or operate a large company, our office is here to help.

# Some of our services include:

Site Selection: If you are a business looking to locate, relocate, or expand in unincorporated Adams County, we can help you find the space you need.

Business Navigator: The Economic Development team is here to help you navigate county processes, including land use, permitting, and development. We can also connect you to our network of technical training, workforce, utility, and economic development partners at the municipal, regional, and state level.

Incentives: We execute performance-based financial and non-financial incentives on a case-by-case basis for commercial development in Adams County. We help guide you and work with you to get your project done.

Data & Market Research: We have access to the most current data and information to help with your business planning and decisions, including demographics, macroeconomic trends, competitor analysis, and labor statistics.

Business Registration Program: Adams County's Business Registration Program allows businesses to sign up to receive updates on county resources and other relevant news. The registration is voluntary and open to all businesses located within Adams County. Enterprise Zone Program: The Colorado legislature created the Enterprise Zone (EZ) Program to encourage development in economically distressed areas of the state. The 16 designated Enterprise Zones have high unemployment rates, low per capita income, or slow population growth. In designated Enterprise Zones:

- Businesses are eligible for state income tax credits and sales and use tax exemptions for specific business investments.
- Taxpayers who contribute to EZ projects may earn income tax credits.

To determine if your business is located within an EZ, please visit oedit.colorado.gov/enterprise-zoneprogram and search your address within the interactive Enterprise Zone map. If you're still unsure, please reach out to our team, and we will help you determine if you are eligible for the program.

A business can earn credits for adding net new employees, providing qualified job training, or investing in business personal property, and more. Details on some of the Business Tax Credits available are:

- Job Training Tax Credit (12% of eligible training costs): Businesses can earn a state income tax credit for 12% of eligible job-training costs for employees working within the EZ.
- New Employee Tax Credit (\$1,100 or more per net new employee): Businesses can earn a state income tax credit of \$1,100 per net new employee.
- Investment Tax Credit (3% of business personal property investment): Businesses can earn a state income tax credit for 3% of an investment in business personal property.

# LICENSES, PERMITS, INSPECTIONS, CERTIFICATES, AND REGISTRATIONS

As a business in Adams County, there may be certain requirements you need to fulfill, such as licenses, permits, inspections, certificates, and registrations. This section contains a frequently used list of those items you may need to obtain from the county and other organizations to conduct business. Though this is a relatively comprehensive overview, there may be further licenses, permits, reviews, and approvals you may need to complete to legally operate that may not be listed here.

Therefore, when in doubt, reach out! Adams County is passionate about assisting businesses and making sure you have the information you need to be successful. If you are unsure of the requirements you need to fulfill to be compliant, our Economic Development team is your starting point to help guide you to the most appropriate contact. # **LICENSES**

### LIQUOR LICENSE **<**

Licenses or permits for the sale of alcoholic beverages are required in unincorporated Adams County. Colorado liquor and beer retail licenses are issued by both county and state licensing authorities. All license or permit applications must be submitted to Adams County local licensing authority and given approval prior to filing with the State of Colorado Liquor Licensing Division.

# SPECIAL EVENT PERMIT (LIQUOR) **\**

A special events permit is a temporary permit for the sale of liquor (by the drink only). Applicant must be a qualifying organization, per C.R.S. § 44-5-102.

### RETAIL FOOD LICENSE (RFE) **\( \lambda**

If you are planning to sell or serve food to the public, then you will need to apply for a Retail Food License. A Retail Food License is not needed for instant hot beverages, bottled or canned beverages, commercially pre-packaged foods such as chips and candy, or if you operate under the Colorado Cottage Food Act. Important note regarding change of ownership: Retail Food Licenses are nontransferrable. Therefore, the new or prospective owner of an existing RFE is required to obtain a new license in the name of the new owner prior to serving or selling food or drink to the public.

### SPECIAL FOOD EVENT LICENSE **<**

A Special Event food establishment operates at a fixed location for a period of time not to exceed 14 consecutive days in conjunction with a single event or celebration. All food vendors participating in a Special Event must have a license to operate as either a Mobile Food Unit or as a Special Event Vendor.

Both the vendor(s) and event coordinator need to fill out respective applications prior to the special event.

# MOBILE FOOD TRUCK/PUSH CART LICENSE **\(\)**

Retail food facilities that are mobile, such as mobile food trucks and push carts, are required to obtain a retail food license.

### BODY ART LICENSE **\(\)**

Body art includes tattooing, piercing, and scarification. Adams County Health Department (ACHD) licenses and inspects all the body art facilities in our jurisdiction to ensure the facility is in compliance with the regulations, and precautions are taken by the artist to prevent diseases.

### MARIJUANA LICENSE <

Adams County currently allows recreational marijuana facilities only. This includes retail marijuana stores, retail cultivation facilities, retail marijuana product manufacturers, marijuana hospitality businesses and retail marijuana hospitality and sales businesses. A cap is in place allowing up to 17 marijuana facilities within unincorporated Adams County.

# PUBLIC DANCE HALL LICENSE **KK**

The public dance hall license is a county license only, for businesses in the unincorporated portions of the county. The license allows for patron dancing, not employee dancing.

# SOLID WASTE HAULER LICENSE **\(\)**

All solid waste haulers that collect and haul waste in unincorporated Adams County must obtain a license. Solid waste includes trash, recyclables, organics, junk, construction and demolition debris, and other bulky materials.

# INSTALLER LICENSE FOR ON-SITE WASTEWATER TREATMENT SYSTEM (OWTS)

The installer license for OWTS is equivalent to a contractor license and is required to install on-site wastewater treatment systems in either incorporated or unincorporated Adams County.

# CLEANER LICENSE FOR ON-SITE WASTEWATER TREATMENT SYSTEM (OWTS)

The cleaner license for OWTS is equivalent to a contractor license and is required to clean on-site wastewater treatment systems in either incorporated or unincorporated Adams County.

# **PERMITS**

# CHANGE OF USE **<**

A Change of Use permit is required to establish a new or different use on the property; the new or different use must be permitted within the zone district.

Example: Auxiliary warehouse to rec center

# TEMPORARY USE **\(**

A temporary use permit authorizes a specific use of temporary nature for a designated period of time, for no more than 90 days per calendar year.

Example: Firework stand, Christmas tree sales, roasted chilis stand, etc.

# CONDITIONAL USE **(**(()

Conditional uses require more discretionary review than permitted uses as it relates to zoning and land use. Some uses are identified as conditionally approved in the county's development regulations and are required to meet performance standards designed to improve compatibility and reduce impacts on adjoining properties.

# **BUILDING PERMIT**

A permit is required when you construct, enlarge, alter, repair, move, demolish, or change the occupancy of a building or structure, or to erect, install, enlarge, repair, remove, convert, or replace any electrical, gas, mechanical, or plumbing system or when you construct, place, or modify a sign.

# OIL AND GAS FACILITY PERMIT (OGF) <

Any new, or major modification to an existing, upstream oil and gas operation located in unincorporated Adams County must obtain an Oil and Gas Facility Permit. This local permit is required in addition to state permits.

# SEPTIC SYSTEM USE PERMIT (ON SITE WASTEWATER TREATMENT SYSTEMS) <

An OSWT license is needed when:

- A sale or change of ownership of a property (with certain exceptions)
- A Change of Use of the property (i.e. a residence to a business)
- When two or more bedrooms are added to a home.

Other reasons deemed necessary by the Adams County Health Department

# **INSPECTIONS**

# BUILDING INSPECTION(S) **\(**

A series of inspections will be required depending on the scope of work detailed within your approved plans outlined in your building permit.

Required building inspections could include concrete encased electrode, temporary power/construction meter, underground plumbing, underground electrical, exterior sheathing, rough Fire District, rough electrical, rough gas piping, ceiling grid, and more.

A final building inspection will also be required prior to occupancy or moving anything into the structure.

# CHILD CARE FACILITY HEALTH INSPECTION(S) <

Adams County Health Department (ACHD) conducts risk-based routine health inspections for licensed child care facilities as well as opening inspections for new child care facilities or those undergoing a change of ownership. Site evaluations for existing facilities undergoing licensing changes may be required.

# RETAIL FOOD/FOOD TRUCKS/CARTS **\**

New establishments are required to schedule a pre-opening inspection by ACHD.

Restaurants are normally scheduled for one to three inspections per year, depending on the complexity of the menu, how much food is made from raw products, how much food is made in advance rather than cooked-to-order, whether there has been a suspected or confirmed food-borne illness outbreak or enforcement action, and if the restaurant serves a highly susceptible population.

Inspections are also required for food trucks and push carts.

A change in ownership of a retail food establishment warrants a Change in Ownership Inspection.

# BODY ART ESTABLISHMENTS **\(\)**

Body Art Establishments will be inspected on an annual basis and as may otherwise be warranted by complaints or previous violations, as determined by ACHD.

This is in addition to pre-opening inspection and any applicable remodeling inspections conducted by ACHD.

# POOL & SPA **《**《

ACHD inspects public and semi-public pools, and water features, including pools and spas at childcare centers, recreation centers, health clubs, schools, and mobile home parks twice a year.

New establishments are required to schedule a pre-opening inspection.

There are 10 fire districts that serve unincorporated Adams County. Each fire district is responsible for plan review and enforcement of the International Fire Code within their district.

# CERTIFICATE OF OCCUPANCY (CO)

A Certificate of Occupancy may be obtained by the Building Safety Division the day following the completion of the final building inspection if all conditions have been met. A CO is needed before a business can operate.

If anything changes that is stated on your existing CO, you may need to obtain a new CO. Examples of such changes could include occupant load changes, sprinkler changes, change in usage classification, etc. A CO is also administered with the completion of new construction or major renovations that previously received a proper building permit and inspections.

# **Opening a Business in Adams County**

The following materials will help streamline the business approval process by making sure you have all the correct documentation and have met all requirements for a successful opening.

You may not need approvals and permits from all the listed departments and agencies. If you have any questions, please contact the county for guidance. It is recommended ALL new businesses first call the Community & Economic Development (CED) Department at 720.523.6800 before opening, expanding, or relocating in unincorporated Adams County.

The information provided is intended to provide a general overview of the processes and common steps involved and it is not intended to replace project-specific, detailed advice that may be required when opening a new business. The content provided here is not intended to be a substitute for any county department's project-specific guidance. Always reach out to the appropriate county department with any questions you may have regarding a specific process or issue.

Contact CED's Economic Development Division at economicdevelopment@adcogov.org and answer business-specific questions to:

• Understand available resources and programs.

- Gain assistance navigating processes and/or requirements.
- Get connected with other departments.

Planning staff will determine if a Change in Use permit is required for your business.

Complete a **Change of Use** application and submit through the county's **E-Permit Center**. The applicable fee for processing the Change of Use Permit application may also be paid through E-Permit Center.

**Initial Submission:** Application reviewed for completeness and compliance with zoning regulations. Additional information or revisions may be requested if necessary.

Internal Review: County reviews application, including reviews by the Planning, Building Safety, Engineering, and Environmental Divisions.

**Comment Report:** Reviewed application packet provided to applicant. All comments in reviewed application packet must be addressed. Applicant should contact all departments included in the comments section.

Finalize Change of Use: After all review comments are addressed and the application is approved, an inspection must be scheduled. All Change of Use permits require a follow-up inspection. Permit approval is contingent upon passed inspection.

Building permits may be required and can be submitted on the county's E-Permit Center.

Any required building inspections must be completed and passed.

Certificate of Occupancy is issued by CED's Building Safety Division, and the business may open to the public.

Additional contact with CED's Planning Division may be required for land use review, zoning regulations, and area compatibility. **Contact the Planner** of the Day at: CEDD-POD@adcogov.org or 720.523.6800.

Change of Use Required Examples:

- Changing from one commercial use to another.
- Significant modifications to the building or property

Review of a Change of Use Permit may include, but is not limited to, parking, architectural review, landscaping, lighting, traffic-related improvement, and site drainage.

Depending on any construction work or improvements, additional approval from the ACHD or local fire district maybe required.

# **Building Permit General Process**

A permit is required when you:

- Construct, enlarge, alter, repair, move, demolish, or change the occupancy of a building or structure.
- Erect, install, enlarge, repair, remove, convert, or replace any electrical, gas, mechanical, or plumbing system.
- Construct, place, or modify a sign.
- **General Commercial Industrial Permits:** Building permits can be submitted on the county's E-Permit Center website.
- **Permit Application Submittal:** Plan review fees must be paid through the E-Permit Center. Please review the appropriate checklist to verify all the required documentation is included in your submittal. Required documents include, but are not limited to, site plan, complete architectural plans and details, and mechanical/electrical/plumbing plans.

**Contractor Registration:** A general contractor and subcontractor(s) must be identified prior to issuance of permits. If the contractors are not registered, they must register through the E-Permit Center.

**County Review:** County will review and provide comments on the submitted application. Applicant must address all review comments. Once complete, any remaining building permit fees must be paid through the E-Permit Center. Construction plans will be approved, and the permit will be issued.

Construction: Work may begin. Once a permit has been issued, it is the responsibility of the applicant to schedule inspections.

**Finalizing Permit:** The Building Safety Division receives clearance from other county departments involved with the development or work completed. If other county departments have requirements, these issues are to be completed before the Building Safety Division will issue a Certificate of Occupancy.

**Certificate of Occupancy is issued.**

Incomplete submittals will not be accepted.

Adams County offers four classifications of general contractor licenses: Class A, Class B, Class C, Class D.

Inspections must be scheduled 48 hours in advance online through the E-Permit Center or by calling 720.523.6320.

To request a Certificate of Occupancy, please follow the process below: a. Upload all required documentation to the permit through your E-Permit Center account. b. Send an email to epermitcenter@adcogov. org requesting a Certificate of Occupancy along with your Building Permit number.

- County
  - We do not require a business license at the county level. However, please consider registering your business to stay informed on news and updates as it relates to conducting business in Adams County.

A cap is in place allowing up to 17 marijuana facilities within unincorporated Adams County.

Tip: We recommend contacting our Planning & Development team prior to signing any sale or lease agreements to determine if you can legally operate your business at that location.

In various capacities the team oversees licenses and/or inspections as appropriate for retail food establishments, body art facilities, child care facilities, pools, spas, water features, on-site waste water treatment systems, and more.

### **Plan Reviews**

In addition to required licensing and inspections, ACHD also requires plan review in certain instances for construction, remodeling, or modifications to restaurant, child care, and body art establishments, as well as public and semi-public pools. - Sales taxes are imposed upon the selling transaction of most goods in the State of Colorado. Adams County does not directly collect sales and use tax. The Colorado Department of Revenue (CDOR) collects sales and use tax for most counties. Marijuana tax is collected by Adams County.

# **Property Taxes**

The County Assessor is responsible for discovering, listing, classifying, and valuing all property in the county in accordance with state laws.

- Real Property
  - Real property is revalued every odd-numbered year (two-year cycle).
  - Real property is generally known as the land and the buildings or fixtures permanently attached to the property.
- Personal Property
  - Personal property is revalued every year.
  - A majority of businesses have personal property that is taxable, and personal property must be reported to the Assessor every year. Personal property is generally known as portable or movable items used for income production.
    - Examples include furniture, fixtures, computers, signage, restaurant equipment, office and business equipment, furniture in a rental unit, industrial machinery, and any other equipment used to function and operate a business.
  - All personal property is taxable unless it is specifically exempt by law. Exemptions include, but are not limited to, inventories for resale, materials, supplies consumed, and agricultural equipment.
- The Assessor's Office also handles property tax abatement. Contact them for questions and information regarding eligibility, process, deadlines, and more.
- Please notify the Assessor's Office when closing your business.

The goal of Code Compliance is to maintain and improve the safety and beauty of Adams County. To accomplish this, the Adams County Board of Commissioners enacts ordinances and regulations to address issues that may be detrimental to the health, safety, economy, and general welfare of residents. Code Compliance enforces these ordinances and regulations for the use of all zoned properties in unincorporated Adams County.

Common regulations include:

- Land use (special/temporary uses, conditional uses, variance)
- Accessory structures
- Property maintenance

- Vehicles (inoperable, too many, commercial vehicles stored on a residential property, parking surface, etc.)
- Environmental blight (junk, trash, overgrown grass, scrap metal, machinery, etc.).

Code Compliance does not include enforcement on abandoned vehicles, illegal parking, or speeding. Please contact the Adams County Sheriff's Office at 303.288.1535 for these issues.

CASP features two 8,000-foot runways, three full precision instrument landing systems, and east- and west-side ramps. With its ample room for growth, CASP is poised to expand its general aviation and aerospace operations. # **FAQS**

The Economic Development team understands business owners have a lot of questions. Through our work at the county, and in collaboration with other divisions, we've identified the following as the most common questions for starting, operating, or owning a business in Adams County.

### Licensing

### "Do I need a business license to operate in Adams County?"

Adams County does not have a business license requirement. However, it is required at the state and city level. If you are located in a city or town, you will need to license your business with your local government as well as register your business with the Colorado Secretary of State. Though the county does not have a required business license, we do have a voluntary business registration program. More information is available on pg. 15.

# "My mailing address says Denver. However, I was told I am located in Adams County, not the City and County of Denver. How do I know if I am located in Adams County?"

There are mailing addresses within unincorporated Adams County that state your city as Denver, even if you/ your business are not actually located in the City or County of Denver. ### **Utilities**

### "What utilities does Adams County provide?"

Adams County's only utility service is stormwater. We maintain the stormwater infrastructure through our Public Works Department. Energy (electric and natural gas), broadband, and water and sewage are provided by various private and quasi-governmental entities.

### **Home-Based Businesses**

"I conduct business from my home in unincorporated Adams County. Do I need a special license or permit specific to home occupation(s)?"

We do not have a license or permit specific to home occupations; however, you must abide by our Development Standards and Regulations. Information for Home Occupations as it relates to our Standards and Regulations can be found in section 4-03-03-02-07.

If you are parking a commercial vehicle on your property that is over 10,000 lbs gross vehicle weight (GVW), a permit is required. Regulations can be found in section 4-03-03-02-14.

No, ACHD does not license pools, but ACHD does charge an inspection fee, and they inspect public and semi-public pools twice a year.
