Specifically, the Board will consider adoption of a resolution authorizing the issuance of the District's General Obligation (Limited Tax Convertible to Unlimited Tax) Bonds Series 2020A in a maximum principal amount not to exceed \$4,000,000, and its' Subordinate General Obligation Limited Tax Bonds Series 2020B in a maximum principal amount not to exceed \$650,000 (collectively, the "Bonds") for the purpose of paying or reimbursing the costs of public improvements for the District. Pursuant to the Supplemental Public Securities Act: (i) no legal or equitable action brought with respect to any legislative acts or proceedings in connection with the authorization or issuance of the Bonds may be commenced more than thirty days after the authorization of such Bonds pursuant to the aforementioned resolution; and (ii) the members of the Board may participate in this meeting and may vote on the foregoing matters through the use of a conference telephone or other telecommunications device.

The Board will also take up such business as may come before the Board. The meeting is open to the public.
